FAMILY LAW DOCUMENT CHECKLIST

One of the most important documents family law clients usually are required to complete is the Form 13 or 13.1 Financial Statement, a prescribed form under Rule 5-1 of the Supreme Court Family Rules. It requires information on the client's income, expenses, assets, and liabilities and is frequently appended as schedules to family law agreements as evidence of full financial disclosure by both parties.

Section 4 (1) of the Family Law Act of Ontario defines **property** as any interest, present or future, vested or contingent, in real or personal property and includes,

- (a) property over which a spouse has, alone or in conjunction with another person, a power of appointment exercisable in favour of himself or herself,
- (b) property disposed of by a spouse but over which the spouse has, alone or in conjunction with another person, a power to revoke the disposition or a power to consume or dispose of the property, and
- (c) in the case of a spouse's rights under a pension plan, the imputed value, for family law purposes, of the spouse's interest in the plan.

Section 4 (2)of the Family Law Act defines **excluded property** as: Property acquired by either spouse before the relationship between the spouses began; this could include gifts or inheritances, a personal property settlement, or proceeds from an insurance policy. Any increase in the value of **excluded property** is considered from the date it is received to the date of separation to be family property.

If your separation involves the division of property or child or spousal support, you will need to gather documents for any of the following assets, debt expenses, or income that are relevant to you or your family:
